This workshop will provide an overview of the grievance process that is mandated by law with focus on the steps that are unique to each contract and tips for navigating the procedure.

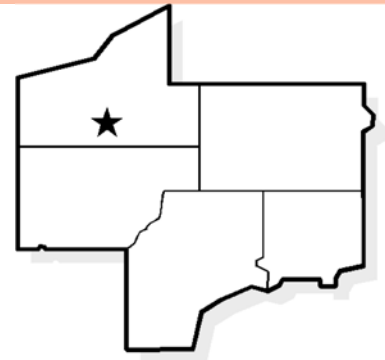
