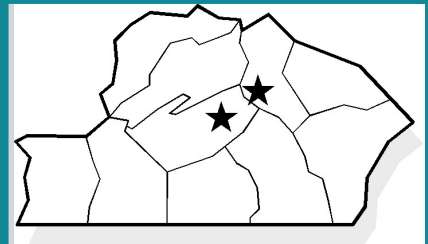
Know your rights under the Family Medical Leave Act and other leaves of absence in your contract.

Implications of Special Education for Educational Support Staff

This course is great for paraprofessionals who have just entered the profession and a good review for those who have multiple years of experience. The course discusses how behaviors should be handled for students with disabilities. There are multiple examples of how educational and IEP teams come up with positive methods to use to move students in a more positive direction. The issues of restraints and seclusion are addressed, and some key points made in PA regulations. We will discuss the ever-increasing number of individuals with autism being identified and some of the problems being faced as these students arrive at adulthood. The discussion shows you how important a role you play in helping these students achieve as they move towards their post-school goals. Several other topics will be discussed in a Q and A format.
