Members of the local met with hospital administration to discuss staffing issues, wages, and scheduling concerns and were able to reach several agreements to improve working conditions moving forward. Additionally, Nancy Morgan, who serves as president of her local, was re-elected as HealthCare-PSEA's vice president at the HealthCare-PSEA House of Delegates. As always, the Southwestern Region and HealthCare-PSEA are proud of our front-line health care workers at Highlands and across the state!

## Indiana Registered Nurses Association

The Indiana Regional Medical Center experienced a substantial drop in patient census within several of their units beginning with the onset of COVID-19. The patient numbers rebounded, but they remained well below normal levels. Consequently, the hospital chose to furlough 32 nurses represented by the association until patient census numbers rebounded in their specific units. Additionally, nine nurses saw their hours reduced below their normal levels but kept their jobs.

Union leaders and HealthCare-PSEA staff worked with the administration to ensure those furloughs and hour cuts occurred in

compliance with the contract. Some furloughed nurses chose to bump into other jobs for which they were qualified, per the contract's provisions.

Continuously, union leaders and staff pressed the administration to return the nurses back to work as patient census rebounded in some units. Recently, 17 furloughed nurses were back working, and two of the nurses who had their working hours reduced were returned to normal hours.

Amid this chaotic situation, the local elected officers for the next two years. Unfortunately, two of those elected officers were furloughed, which caused new officers to be selected.

The officers are President Karen Blystone, Vice President Christa Rounsley, Treasurer Deb Minto, Grievance Chair Val Davis, and Secretary Kristy Waltz. They all will serve until the spring of 2022. Working with HealthCare-PSEA staff, the officers immediately began working on a project to boost and strengthen the ranks of union unit and floor representatives. This is with an eye to the timeless work of internal union organizing and building power.

## Somerset Professional Nurses Association

engaged in contract negotiation sessions virtually, and contract proposals have been exchanged by email. Progress has been slow, with a proposed switch to a paid time off system that would combine vacation, sick, and personal leave into one system. This issue is among the items that are being bargained. More bargaining dates were set for September. The current contract is extended through Dec. 31, 2020.

Bill Carnell, association president, and statewide HealthCare-PSEA President Sandi Zubek gave updates on Somerset nurses' ongoing experiences during the COVID-19 pandemic, with an uptick in Somerset County cases and at least one patient death in-hospital from the illness. Members are pleased that President Zubek

was re-elected to lead the statewide organization for the next two years.

Additionally, concerns about having enough personal protective equipment like surgical masks, facial shields, gloves, and N-95 masks remain. Too often, the hospital has nurses using, cleaning, and reusing the same masks more than is preferable to preserve PPE supplies that are hard to find.

In July, SPNA member Kristin Yoder participated in a statewide Zoom conference call with U.S. Sen. Bob Casey of Pennsylvania to promote his new bill that would provide student loan debt reduction, pay new education costs, and otherwise provide more concrete recognition and thanks for the sacrifices and hard work of nurses and other health care workers on the front lines of the pandemic.

Kristin was recruited through our national affiliate, AFT HealthCare, which represents and advocates for HealthCare-PSEA at the federal level in Washington, D.C.

"Like the other front-line workers on this call, I'm facing a really challenging time. I work hard to keep my patients healthy, while hoping that I won't get sick or infect my family or neighbors," said Kristin Yoder.


"Some politicians offer nurses and other health care workers verbal thanks for thoughts and prayers. But this is not enough. Sen. Casey's bill provides us with some support, by easing our financial burden. It helps with student loans, or supporting our kids, or our retirement. The bill is titled the 'Pandemic Service Provider Award Act,'" said Yoder.
